Requirements for a case summary to pass:

- 1) Minimum score of 70% (259 out of 370 points)
- 2) No individually graded section received a score of "0"
- 3) Both overall impressions sections (A & B) received a "Yes"
- 4) Total document word count is 1,400-1,700 words (does not include tables, lab results, images, references, or endnotes)
